#### MONTHLY BOARD REPORTS

# Report of the Chair, Dr. Keith Gilless

Chair Gilless expressed condolences to the family and friends of Daniel Laird, a Helitack Captain from Tahoe National Forest, who passed away on March 27, 2019 in a helicopter accident while conducting a prescribed burn. He also expressed condolences to the family and friends of a Public Works employee who passed away recently in Calaveras County. The Chair expressed optimism related to the 45-day report recently released by CAL FIRE and the actions that will come from Executive Order N-05-19 related to wildfire preparedness.

#### Report of the Director, Thom Porter

Director Porter reported on the following matters:

#### **Fuel Reduction Accidents**

• Director Porter echoed Chair Gilless's sentiments regarding the two accidents that occurred recently.

#### **Forest Health Grants**

- Projects from the 45-day report related to fuels reduction and forest resiliency, as well as Department fuel reduction efforts were reported on. The projects from the 45-day report include many projects that had already applied for Department grants.
- \$63.4 million for 16 projects 3 forest legacy, 13 landscape level and forest resilience and fuels-related work
- The Department is working toward meeting the goal of 500,000 acres of treated land annually.

#### **Fire Protection**

- The Department is working on ensuring that all resources and personnel are reachable at all times. By the beginning of peak season all equipment and personnel will be visible at all times using a 3-tiered system (cellular, satellite, and VHF radio).
- Airframes are in development and a new helicopter will be operable soon.
- Several C-130s are currently being examined for retrofitting and are anticipated to be usable in 2021.
- A decrease in inmate crews has left the Department at 71% of capacity.
- The Ventura Training Center (soft-skills training) for ex-offenders interested in a firefighting career had the first graduating class of 14 students. Word is spreading about the Training Center and striking interest in the inmate crew program.

#### **Utility Mitigation Program**

- Eight utility mitigation plans have been reviewed and submitted to the CPUC for their feedback.
- Weekly meetings are occurring with major utility providers and the CPUC to resolve power shut-off issues and related public safety issues and messaging.

#### **Fire Prevention Grants**

- The Department has received \$190 million in applications for 290 projects.
- Thirty-five projects in the 45-Day Report were in the pool of applications. They will be priority projects.

## Fuels Reduction, Prescribed Burning, and Defensible Space Inspections

 Approximately 42% of the targeted 250,000 Defensible Space inspections, 11,000 acres of prescribed burns, and 9,000 acres of other fuel reduction have been conducted this year.

#### 45-Day Report

 The 35 projects identified in the 45-Day Report would contribute 90,000 acres of fuel reduction. The goal is to complete these projects by the end of the year. The public can get more information on the Cal Fire website as well as from their local CAL FIRE Unit.

Public Comment: Lawrence Camp, member of the public: Can the Best Management Practices be posted on the CAL FIRE website or another public website? Director Porter indicated that he has been working with the Natural Resources Agency to get this completed, and it may already be done.

**Public Comment: Susan Robinson, member of the public**: How will CAL FIRE better recognize and get the word out about home hardening which may be as or more important than vegetation management in hot, windy ember fires? Director Porter responded with information about home hardening outreach and CAL FIRE apps centered around home hardening and emergency safety.

## Report of the Executive Officer, Matt Dias

The Executive Officer discussed the ongoing implementation of AB 434 which requires ADA compliant websites and documents by July 1, 2019.

  - The Executive Officer discussed key legislation that may affect the Board, including AB 1160, AB 1823, SB 632, SB 462, AB 394, and SB 69.
- Review of Lumber Assessment Regulations
  - A required review of the current Lumber Assessment Regulations has been completed. No necessary changes have been identified.
- Update on Emergency Proclamation
  - The Executive Officer felt that this item was sufficiently covered under Director Porter's report.

  - A general agreement was reached on amendments to revisions to rule text during Committee discussions. The Committee directed staff to develop performance-based alternatives revisions for consideration.
- Discussed additional Emergency Regulations for the Working Forest Management Plan.
  - The North Coast Regional Water Quality Control Board requested that an Erosion Implementation Plan embedded in the WFMP regulatory text. Committee direction was for the North Coast Board, Coast Acton Group, and other stakeholders to collaboratively develop and bring forth language as it relates to the requested regulatory revisions for consideration at a future committee meeting.

Resource Protection Committee – Chair Susan Husari reported on the following matters:

- Safety Element Review for the City of Portola
- Discussion and Review of Existing Board Regulations for Maintenance of Utility Right of Way
  - Staff has been directed to expand on the information provided to the Committee for future discussions. The Committee intends to work closely with the CPUC, relevant utility companies, and CAL FIRE's Planning Department as they continue to review these regulations.

## **Report of Board's Advisory Committees**

Effectiveness Monitoring Committee – Chair Sue Husari

Chair Husari reported that the principal investigators of funded projects provided updates on their progress. She indicated that there may soon be some findings associated with certain projects that may help inform the Board on future regulatory matters. It was also mentioned that due to the good work of Board staff, three applications to fill the two vacant academic seats on the EMC have been received.

Range Management Advisory Committee – Brandi Goss, Environmental Scientist

 Brandi Goss, Environmental Scientist, reported on RMAC's progress related to their 2019 Priorities consisting of targeted grazing, rangeland science and education, and continued engagement on regulatory development from various state agencies. RMAC is communicating with various agencies to help develop collaborative projects related to grazing and targeted grazing research.
