Resource Management

Forest Practice Program

Plan Submissions (through 04/30/2019)

- **THP Submissions**: The number of THP submissions through April was approximately 10% lower than the number of submissions through April of last year (65 compared to 72 in 2018).
- NTMP Submissions: The number of NTMP submissions through April was 50% lower than the number of submissions through April of 2018 (4 compared to 8 in 2018). Approximately 11 NTOs have been submitted this year; about 52% less than the number of NTO submissions last year (23 in 2018).
- Exemption Notice Submissions: Exemption submissions were approximately 19% lower through April compared to the same period last year (513 compared to 634 in 2018). The acreage covered was approximately 51% lower (1,048,603 acres compared to 2,141,253 acres in 2018).
- Emergency Notice Submissions: Emergency Notice submissions were approximately 12% lower through April of 2019 than submissions over the same period last year (74 compared to 83 in 2018). However, Emergency Notice acreage this year has increased significantly over last year (10,609 acres compared to 4,741 acres in 2018).
- Plan Approval: The number of THPs approved through April is approximately 18% lower than the number approved for the same period of 2018 (77 compared to 94).
 About 6 NTMPs have been approved in 2019 compared to 3 approved during the same period of 2018.

Watershed Protection Program Update

• Staff have begun Exemption and Emergency Notice monitoring work for 2019. Initial emphasis has been placed on 1052.1 Emergency Notices, with protocol and digital data revisions completed. Data was collected for four Notices burned by the Tubbs Fire in Sonoma County the week of April 8th, working jointly with North Coast Regional Water Quality Control Board staff. Additionally, data was collected for two notices in Shasta County burned by the Carr Fire the week of April 22nd. A total of 54 Emergency Notices will be evaluated in 2019. 1038(c,c(6)) Fire Hazard Reduction Exemption Notices will also be monitored this year.

Resource Protection and Improvement Program

Urban and Community Forestry (UCF)

 The Director made determinations on Urban and Community Forestry Grant Awards on April 30. The bulk of the awards will be from Proposition 68 funds (approximately \$13.5 million), with California Climate Investments making up the remainder (approximately \$3.5 million). It is expected that this will fund 20 to 30 grant projects.

Demonstration State Forests

Boggs Mountain

Boggs is open for day use only. Camping and fires are prohibited.

- On the week of April 12th, an LTO's skidder and loader were both shot with numerous .40 caliber rounds. The FOBM trail building trailer was also shot, and the tires were slashed.
- Drew Coe led an interpretive field trip for a Humboldt State University Soils 460 class on April 13th. The students were permitted to camp at Boggs Mountain Demonstration State Forest for the night prior to the field trip.

Jackson

- A new three-sided interpretive display was installed at the Caspar Woods Schoolhouse in April. The two interpretive panels describe the history of the schoolhouse and how it was moved from logging camp to logging camp.
- Plans for a new 2-mile section of trail has been finalized and the Mendocino Coast Cyclists will construct it this summer.
- Northern spotted owl (NSO) surveys at several early season spot check plans have been completed. More barred owls have been heard than NSO. No nesting NSO have been found to date.
- Three new potential marbled murrelet habitat areas at the west end of SF Noyo River have been designated by California Department of Fish and Wildlife through preconsultation field visits.

Mountain Home

 Mountain Home is struggling to meet the sampling, monitoring and reporting requirements associated with their permit from the local water district for providing drinking water in their campgrounds. Forest Manager Jim Kral is considering the option of providing non-potable water only if he can't resolve this issue.

Soquel

- Staff prepared a draft MOU between CAL FIRE and CDFW to continue the annual electo-fishing data collection effort. This effort was dropped by NMFSs this past summer due to the retirement of a key staff member. The MOU with CDFW will assist in the continuation this important 25-year data set on fish population statistics within the East Branch of Soquel Creek.
- Staff led a field tour for students from a Swedish University on April 4th as part of their research into sustainability. This was a first introduction to forestry and people who work in the woods as their work has mostly been focused on the urban environment.

Lewis A. Moran Reforestation Center (LAMRC)

- As of April 24, 2019, the 30,000 seed sown has germinated and is exhibiting between an 87% and 93% survival rate.
- LAMRC continues to work with Technical Services on the contracts for the restoration
 of the two existing greenhouses and construction of the new greenhouse/shade house.

California Forest Improvement Program (CFIP)

 The implementation of the FI\$CAL Program has significantly impacted CFIP. Landowners/Grantees on average have had to wait 3-4 months to receive their reimbursement. We are receiving numerous complaints on this issue from multiple parties, including the Forest Landowners of California, California License Forestry Association and many private parties.

Forest Legacy Program

The 967 acre Jacoby Creek Forest Legacy Project closed escrow on April 23rd. The 49 acre Forsyth Legacy Project closed on April 12th.

Forest Pest Management

- Staff has been working on the various sub-committees of the Invasive Shot Hole Borer Planning group of the California Invasive Species Advisory Committee to develop plans for the use of state funds to combat the invasive pest complex in California.
- CAL FIRE Pest Management Staff will be offering a training session on forest insects and diseases for foresters from CAL FIRE and the USFS in Redding this coming June.
 If space is available, the training may be opened to other students outside of these two organizations.
- CAL FIRE will be hosting the western bark beetle, wood borer and defoliator working meeting in southern California in October.
- The 2018 California Forest Pest Conditions Report has been completed and will soon be available online.

Fire and Resource Assessment Program (FRAP)

- The Program made final selections and notified applicants for California Climate Investment Research Grants. A total of 10 Research Grants were selected - 4 on State Forests.
- FRAP has a new program for prescribed burn monitoring. A field coordinator position
 was hired and staff is establishing a contact with the University of California for field
 monitoring crews.

 FRAP is in discussion with the USFS Pacific Northwest Research Station for Forest Inventory & Analysis Intensification. This would result in moving from a 10-year remeasurement cycle to a 5-year cycle.

Climate and Energy Program

Forest Health Grant Program

 The CAL FIRE Forest Health Grant Program awarded \$63.4 million of California Climate Investment funds. There were 16 projects that were selected to receive grant funds. Of those 16, 3 were Forest Legacy Projects. Fire Protection

Fire Protection Program

Law Enforcement/Civil Cost Recovery

- Last month, CAL FIRE Law Enforcement made 12 arrests and issued 36 citations (excluding PRC 4291).
- Last month, CAL FIRE received \$827,677 resulting from Civil Cost Recovery actions.

Fire Protection Operations

- To date, including installs in San Bernardino Unit, CAL FIRE has completed 960
 AVL/MDT mobile installs. Remaining installs include San Luis Obispo Unit (52), San
 Diego Unit (86) and Riverside Unit (88) for a total remaining of 289. It is anticipated
 that all installs will be completed by September 2019.
- Operations Staff has been meeting with CalOES in regard to the Utilities Public Safety Power Shutoff (PSPS) program for 2019. Command and Control is meeting with the State Warning Center and State Operations Center Operations Manager to discuss exact information to be shared, distribution process, and possible incorporation of PSPS GIS layers into SCOUT.
- Operations staff also met with the Independent System Operator (ISO) on April 29, 2019, to present a Fire Season 2019 outlook and share information.
- Staff have conducted multiple meetings with the National Guard; attended Coop Agreement meeting on Exhibit C - Incident Awareness and Assessment (IAA), fire detection and notification trial will begin with CAL FIRE Intel after eight months of discussion (funded from Federal Training funds which run out July 1). Will also be involved in IAA training in Ione the week of May 6th.

CAL NENA – (CA National Emergency Number Association (911)) Because of this
year's attendance CAL FIRE has secured positions on each of the Regional NG 911
Task Forces (Exception of LA City) to help "coordinate region specific communications
structure for feedback and input, and make procedural decisions for the regional
ESINet (Emergency Services IP Networks), Next Generation 911.

Aviation Management Unit/Tactical Air Operations

- All Southern Region Air Bases staffed on May 1, 2019. Northern Region Air Bases are scheduled to all go on June 1, 2019.
- S-70i Blackhawk Helicopter Implementation Group continues to plan and prepare for delivery of new helicopters. The first aircraft is tentatively scheduled for delivery in early July. Work continues on operations, training, infrastructure needs, staffing models and maintenance requirements.
- The Interagency Air Attack Course is underway and beginning its second and final week. Total of 18 students (9 Federal, 8 CAL FIRE and 1 LA County FD).
- CHP Aviation Training will be taking place over the next two months. CAL FIRE is sending personnel out to all of the CHP Air Operations Divisions to train them on our operations and how they can safely integrate into our operations on wildland fires. The goal is to increase aviation coordination and eliminate airspace conflicts.
- The California National Guard (CNG) Fuels Reduction Crews received their initial training and are now functional performing field operations.

Mobile Equipment Management

- Mobile Equipment received the first of three Mobile Command Centers on April 26, 2019, to replace our aging fleet.
- Mobile Equipment Program is actively releasing new chippers, track chippers, track loaders, trailers, pickups, and fire engines to the field.

Cooperative Fire Program

Conservation Camp Program

- The Ventura Training Center (VTC) began its third class of 25 participants on April 15, 2019.
- The Conservation Camp Program has been preparing for the upcoming fire season and the Camps are participating in fire preparedness exercises throughout the state that include hiking, fireline construction and other emergency activities.

• The statewide Conservation Camps population for Wednesday, April 24, 2019: the current statewide shortage of fire crew members assigned to fire crews is 953 (a decrease of 3 from 956 as of April 10, 2019). The inmate population stands at 83% (-4%) of capacity while crew capacity stands at 71% (no change).

Local Government Program

The Local Government Program is distributing Local Government Agreement Budget
Plan documents to the Regions. These plans will need to be reviewed and updated by
the Units to reflect any anticipated position or classification changes in the next two
years. This information is used to ensure the Department has sufficient position and
reimbursement authority for our Local Government Agreements as well as used to load
budget information into FI\$CAL.

State-Federal Program

- CAL FIRE and the California Military Department (National Guard) have signed a 12-month agreement for five, twenty person military fuels crews. The crews will be based out of Fresno (2), Monterey, Auburn and Redding for fuels management projects and possible emergency response.
- This month Cal OES hosted a California Fire Assistance Agreement (CFAA)
 Committee meeting involving all signatory agencies. The U.S. Forest Service (USFS)
 audit discussion consumed the balance of the meeting and resulted in resolution of
 most the 2018 CFAA invoice disputes which prevented the USFS from issuing
 payment. The next CFAA Committee meeting is scheduled for May 3, 2019.

Safety/EMS Program

- Twenty-five students successfully completed the Supervision 5 Exceptional Leadership
 class hosted by CAL FIRE's Executive management. The course focus is a
 succession planning and implementation leadership forum focused on change and the
 State system. Students are highly motivated to learn behaviors of an exceptional
 leader, strategies for moving the Department into the future, working on current issues
 that will make a difference, and an introduction to the CAL FIRE Executive Team.
- The CAL FIRE 2018 Vehicle Accidents report was released in April. Statewide, there
 were 436 vehicle accidents reported an average occurrence of 36.33 accidents per
 month. The Director has set goals for 2019 including:
 - Reduce the occurrence of collisions with stationary objects by 20%.
 - Reduce the occurrence of backing accidents by 10%.
 - 100% of CAL FIRE drivers will obtain their defensive driving certification at least once every four years.

- The CAL FIRE EMS Program processed 44 EMT Certification/Recertification applications that were received in March 2019. Current certified CAL FIRE EMTs: 973
- CAL FIRE's Research and Development Program continues to process research
 proposals and is actively involved in partnership with the Department of General
 Services (DGS) and the California Department of Technology (CDT), Request for
 Innovative Ideas (RFI2) solicitation for Wildfire Management relating to wildfire
 detection and prediction.

Training Program

- Training Center graduations on April 26, 2019, included Fire Fighter Academy (FFA) 3-19 with 47 students, FFA 4-19 with 46 students, and Company Officer Academy (COA) 1-19 with 45 students.
- The Training Center will be starting the following classes on April 29, 2019: HFEO Academy #45 with 20 students and COA 2-19 and 3-19 with 86 students.
- Aviation related classes are finishing up this week with Air Tactical Group Supervisor (ATGS) in Redding this week.
- The CAL FIRE Training Center Dormitory project concrete parking areas making progress with the good weather.
- Staff are making arrangements to hold interviews for a vacant Assistant Chief of Fire Training position.

Office of the State Fire Marshal

Wildland Fire Prevention Engineering

- Staff continue to work with the California Public Utilities Commission (CPUC) in implementing SB-901 and the development of the new Utility Mitigation Plan Program. Staff have completed the review of the 6 IOU and 2 ITO WMPs. The consolidated review documents have been submitted to the CPUC for consideration by the ALJ.
- Continue to analyze multiple proposed legislation on potential impacts to Department and Program.
- Staff continue to work with the CAL FIRE Office of the State Fire Marshal Wildland Urban Interface Building Code Committee in developing a list of low cost home retrofits per AB-2911 (2018).
- Staff continue to analyze the Damage Inspection data.

Fire Plan

- Units are starting to update annual fire plans.
- Staff are working on the annual Fire Plan Report that will be presented to the Board in the near future.
- Staff are working with the Fire Resource and Assessment Program (FRAP) and the Board to begin the SRA (State Responsibility Area) review. Following this review, a remapping effort of the Fire Hazard Severity Zones will begin.

CalFIRS (CAL FIRE Incident Reporting System)

- The 2017 Wildfire Activity Statistics Book (Redbook) is being published.
- The 2018 Wildfire Activity Statistics Book (Redbook) is being completed.

Land Use Planning

- Multiple jurisdictions are currently updating Safety Elements statewide.
- Continued bill analysis on proposed legislation and potential impact to Department and Program.
- Program working on staffing plan for the 2018 AB 2911 subdivision development review.

Fire Prevention Grants

 Awarded 66 fire prevention grants totally \$43 million. Approximately \$33 million is funded from the CCI Greenhouse Gas Reduction Fund and \$10 million from the Community Wildfire Prevention Program. These projects include fuel reduction, planning and public education. About 293 grant applications were received requesting nearly \$190 million.






