## **Resource Management**

## **Forest Practice Program**

## Plan Submissions (through 06/30/2019)

- **THP Submissions:** The number of THP submissions through June was one more than the number of submissions through June of last year (116 compared to 115 in 2018).
- NTMP/WFMP Submissions: The total number of NTMP submissions so far this year was one less than the number of submissions through June of 2018 (9 compared to 10 in 2018). About 34 NTOs have been submitted this year; approximately 61% less than the 88 NTOs submitted through June 2018. The first WFMP has been accepted for filing and is now under review.
- Exemption Notice Submissions: Exemption submissions were approximately 2.5% higher through June compared to the same period last year (1,065 compared to 1,039 in 2018). There were 259 Butte Post-Fire Recovery Exemptions that have been accepted to date, covering an area of approximately 724 acres. Around 15 Forest Fire Prevention Exemptions have been accepted to date for approximately 1,892 acres. Three (3) Small Timberland Owner Exemptions have been accepted for approximately 112 acres.
- Emergency Notice Submissions: Emergency Notice submissions were approximately 16% higher through June of 2019 than submissions over the same period last year (134 compared to 116 in 2018). Acreage in Emergencies this year has increased by approximately 123% (20,910 acres compared to 9,385 in 2018).
- **Plan Approval:** The number of THPs approved through June is approximately 17% lower than the number approved for the same period of 2018 (116 compared to 139). The 6 NTMPs approved as of June 2019 is one less than the 7 approved during the same period of 2018.

# Timber Regulation and Forest Restoration Fund (TRFRF) Activities [Updated from the TRFRF Database (01/01/2019 through 5/31/2019)]

 Since January 1, 2019, the Department has expended 59,833 hours in conducting Forest Practice Program activities funded by TRFRF. An additional 3,729 hours of Forest Practice Program activities not funded by TRFRF has also been completed. Combined, Department staff has recorded 63,562 hours of Forest Practice related activities thus far in the new year.

## Watershed Protection Program Update

- Exemption and Emergency Notice monitoring work is ongoing; monitoring visits to 44 of 54 Emergency Notices remain to be completed this summer. Field testing of protocols developed for 1038(c, c(6)) Fire Hazard Reduction Exemption Notices will be conducted soon.
- CAL FIRE and USFS Pacific Southwest staff participated in the fourth year of Statewide Assessment Monitoring Program bioassessment monitoring work in the South Fork of Caspar Creek during the week of June 24<sup>th</sup>. This work is documenting biological, chemical, and physical impacts associated with the third logging experiment at Caspar Creek. The new 5-year Caspar Creek contract between CAL FIRE and the PSW was fully executed on June 28<sup>th</sup> and will run through December 2024.
- A contract between CAL FIRE and the PSW was approved to help complete the Kings River Experimental Watershed (KREW) study, began in 2000. This project is documenting the impacts of fuels reduction treatments (thinning, prescribed fire, and a combination of thinning and prescribed fire) on streamflow, sediment, and stream chemistry in the southern Sierra Nevada, heavily impacted by the recent bark beetle epidemic.

- Staff helped complete the California Silver Jackets publication, "After Wildfire: A Guide for California Communities." Thirteen state and federal agencies assisted with the production of this document; work began in 2017. Silver Jackets is an interagency partnership program encouraging federal, state, local, and tribal agencies to work together to find solutions for flood risk management issues.
- Staff is working on developing a brief guidance document for addressing Summer Steelhead and Upper Klamath-Trinity Spring-run Chinook Salmon in Timber Harvesting Plans. In June, the California Fish and Game Commission voted to move Summer Steelhead to candidate species status under the California Endangered Species Act (CESA), along with the Upper Klamath-Trinity Spring-run Chinook Salmon that became a candidate in February.

#### **Resource Protection and Improvement Program**

## Demonstration State Forests (DSF)

#### Boggs Mountain and Las Posadas

• A building site for the new forestry office has been selected and a Geo-Technical assessment and percolation tests are scheduled for July. BMDSF staff is preparing the CEQA assessment in support of this project.

#### Jackson

- In conjunction with Dr. Pascal Berrill, and UC Extension's Yana Valachovic and Michael Jones, JDSF hosted the Multiage Forestry Group Spring Field tour on June 13-14. Over fifty foresters attended and learned about long term studies and demonstrations at JDSF from Lynn Webb and Kirk O'Dwyer.
- Timber Operations have commenced on the Sequoia, Camp 8 #2, and Wonder Crossing timber sales. Operations on 23 Gulch and Bear Gulch #2 are anticipated to begin in August.

## LaTour (LDSF)

- The Boucher Timber Sale Agreement was approved on June 21<sup>st</sup>. The pre-op meeting occurred July 1<sup>st</sup> and operations have commenced.
- A team from FRAP assisted in the flagging and data collection of the remaining plots in the FRAP study area internal to the Whitmore fire plantation. Harvest on the study site is planned to start in July.

• Forest Manager, Jason Poburko assisted local Scout Troop 37 with the requirements of their forestry merit badge while they were camping at South Cow Creek Meadow. Their visit included an overview of the goals of LDSF, the goals of the management plan, a silvicultural tour, discussions of tree growth via increment boring and a visit to the lookout. The Scout troop offered volunteer labor as part of a service project and engaged in some serious raking and fuels reduction in the South Cow Campground.

## Mountain Home (MHDSF)

- The Forest opened to the public on Friday, June 7<sup>th</sup>. Frasier Mill, Hedrick Pond and Shake Camp were opened concurrently. Hidden Falls and Moses Gulch campgrounds remain closed due to water delivery issues and road repair needs.
- Two new exemptions were prepared and submitted to continue salvage operations this season.
- A reconnaissance of the Alder Fire discovered high rates of mortality and confirmed that the Miner's Cabin, a popular attraction, was completely burned.
- MHDSF Staff sold five permits for Giant Sequoia cone collection.

## Soquel

- Forest Manager, Angela Bernheisel coordinated an all-day CEQA training on June 21<sup>st</sup> for CAL FIRE staff and local cooperators. 25 people attended from multiple agencies across 3 counties.
- The procurement process through DGS was completed for purchasing the pre-fab Big R bridge for Longridge Road. This project with the contract in place with Algerine West will proceed this summer.
- Forester, Colin Noyes continued work with the Ben Lomond Conservation Camp crews to maintain shaded fuel breaks and road access.
- A Herpetological Survey Report was received for the three surveys completed in May. Foothill Yellow-legged frog egg masses were counted in Amaya Creek and the East Branch of Soquel Creek and observations of adults and juveniles also recorded, along with several lizards, snakes and salamanders.

#### Lewis A. Moran Reforestation Center (LAMRC)

 Jessica Huang, Forestry Assistant II, successfully completed Company Officer Academy on June 14<sup>th</sup>, and has successfully completed her probation. Ms. Huang is back at LAMRC and has resumed her duties as the Seed Bank Manager.  On June 14<sup>th</sup>, the 2019 Cone Crop Survey and Cone Collection Certification Memorandum was sent to CAL FIRE Region Chiefs, Assistant Region Chiefs, Unit Chiefs, Resource Management Staff Chiefs and Unit Foresters. The memorandum includes information on what species for cone collection are a priority. For this season, if a suitable crop is available, LAMRC is prioritizing for collection in those seed zones and species that have been impacted by the Camp Fire, Carr Fire, and the October 2017 fires in Sonoma, Lake, Napa, and Mendocino counties. Survey data is due back to LAMRC no later than July 31<sup>st</sup>.

## **Forest Pest Management**

- A new Gold Spotted Oak Boar (GSOB) find in Trabuco Canyon in Orange County is currently outside the designated GSOB Zone Of Infestation (ZOI). The infested coast live oak is located on Orange County Transportation Authority Property. The tree has been removed and during subsequent surveys another tree was found to be infested and removal is being determined. These trees are 8.5 miles from established GSOB area in Trabuco Ranger District (Falcon & Blue Jay campgrounds).
- A new GSOB find in Bouquet Canyon in LA County is currently within the designated GSOB ZOI. The highly infested coast live oak is 3.75 miles from the established GSOB area in Green Valley and is located at a residence on the Angeles National Forest. This new location is too far for natural spread by the insect and is suspected to be from movement of infested firewood.
- The summer Insect and Disease Committee Field Trip for the California Forest Pest Council will be held on July 16, 2019 in Fort Bragg.
- Pest Management staff joined USDA Forest Service, Forest Health Protection staff to offer a 2-day Forest Insect & Disease Recognition and Management training June 5-6 in Redding. Approximately 19 CAL FIRE Resource Management personnel and 4 federal agency employees attended the class.
- Pest Management staff moderated talks and papers, presented information, and organized a field trip at the 7<sup>th</sup> Sudden Oak Death Science Symposium in San Francisco on June 25-27. The conference was attended by nearly 200 professionals from places as far away as Washington DC, New Zealand, and the United Kingdom.

#### Fire and Resource Assessment Program

- All California Climate Investment research grants have been fully executed. Field work on one of the research grants studying regeneration started at Boggs last week with assistance from FRAP.
- Prescribed burn monitoring field work was conducted in the Sly Park area for planned fall burns.

## Climate and Energy

## Forest Health Grant Program

 The CAL FIRE Forest Health Grant Program awarded \$63.4 million of California Climate Investment funds. There were 16 projects that were selected to receive grant funds. Of those 16, 3 were Forest Legacy Projects. ## **Fire Protection**

#### **Fire Protection Program**

## Law Enforcement/Civil Cost Recovery

- Last month, CAL FIRE Law Enforcement made 14 arrests and issued 45 citations (excluding PRC 4291).
- Last month, CAL FIRE received \$668,749 in reimbursements resulting from Civil Cost Recovery actions.
- Law Enforcement personnel have been participating in numerous illegal firework interdictions throughout the State. The results of these operations will be provided next month.
- On May 20<sup>th</sup>, CAL FIRE Law Enforcement Officers in the Tehama Glenn Unit responded to a fire near Henleyville. The officer contacted an adult male who stated he started three fires. The officer arrested the suspect for three counts of PC 452, recklessly causing a fire and was transported and booked into the Tehama County jail without further incident.
- On May 21<sup>st</sup>, CAL FIRE Law Enforcement Officers working in Shasta County arrested a juvenile for five counts of arson to the vegetation. The juvenile was booked into the Shasta County Juvenile Hall without further incident.

On May 25<sup>th</sup>, from 7 a.m. to 1 p.m., CAL FIRE Shasta Trinity Unit Fire Prevention personnel partnered with the California Highway Patrol, U.S. Forest Service, and the Shasta County Sheriff's Office Boating Safety Unit to provide voluntary safety checks on boat trailers and boats at the Jones Valley boat ramp at Lake Shasta. This event was coordinated as a kickoff to the Memorial Day weekend which is the beginning of the boating season on Lake Shasta. During the five-hour period, 45 vehicles towing boats and 100 persons were contacted. Each person contacted was provided a fire and boating safety message. Several interagency campfire permits were also issued. Boat trailer and equipment inspections revealed a large amount of boat trailers on the road are not being maintained properly. Approximately 50% of the boat trailer axles were observed with leaking or failing inner bearing seals on the hub assembly likely due to age.

## **Fire Protection Operations**

- Computer Aided Dispatch five-year hardware and software Refresh project completed on time and within budget as of June 20, 2019. All ECCs and Training Center workstations have been updated.
- We have completed 1054 AVL/MDT installations, total remaining is 124 (MVU and RRU). Anticipated completion is September 2019.
- SCOUT temporary data sharing agreement/variance is in place and will allow CAL FIRE AVL information to be displayed with cooperators through SCOUT interface. ETA to production is less than two weeks.
- Working closely with the CA National Guard to improve notification and dissemination
  of potential new fire detections. This information will also be placed into SCOUT once
  verified and validated by Region Intel.

## **Aviation Management Unit/Tactical Air Operations**

- The first C-130, Tanker 118, is coming out of the Coast Guard paint shop marked in CAL FIRE colors. We are painting the aircraft as the US Coast Guard vendor has openings even though the retardant delivery system still hasn't been installed.
- The CAL FIRE/CHP Aviation Integration Training has been completed. The Napa Division will not be completed due to multiple personnel vacancies and movement. We will coordinate that training once their personnel transactions are completed. We have seen success from this training during air operations on wildland fires.
- The annual training for the California National Guard (CNG) Aviation Channel Islands facility will take place August 26-30 upon their return from deployment. All other military asset training has been completed and their aviation resources are available to us upon request.
- TAO staff met last week to work on the updates to the Aerial Supervision curriculum. Updates will be completed prior to the next class in April 2020.

## **Cooperative Fire Program**

## **Conservation Camp Program**

- The Interagency Agreement between CAL FIRE and the Department of Corrections and Rehabilitation/Division of Juvenile Justice (CDCR/DJJ) has been extended for one additional year. This will allow for an orderly transition of the program from CDCR/DJJ to California Health and Human Services in 2020.
- Division Chief Robert (Bob) Farias has been appointed as Deputy Chief for the Statewide Conservation Camp Program in Sacramento, effective July 1st; he succeeds Deputy Chief Justin Sanders who retired in May.
- The current statewide shortage of fire crew members assigned to fire crews is 1344 (a shortage increase of 83 from 1261 on June 5, 2019). The inmate population stands at 69% of capacity (-10%), while crew capacity stands at 60% (-8%).

## Local Government Program

 The draft proposal to provide fire protection services to the Rescue Fire Protection District (El Dorado County) has completed the review process by twelve Sacramento Headquarters statewide programs, as required by CAL FIRE Policy. These programs range from Human Resources to Fire Prevention to Mobile Equipment. Upon the resolution of questions/comments raised by the Programs to the Unit Chief, this draft proposal will go before the Director for review and a determination on whether to submit a proposal for services to the Rescue FPD.

## **State-Federal Program**

- The Interagency Agreement for fire protection between CAL FIRE and the Department of Parks and Recreation (DPR) has been renewed for an additional five years. Expiring in 2024, this agreement encourages DPR to prepare wildfire management plans for each park to assist CAL FIRE in potential suppression activities.
- The June 12<sup>th</sup> meeting of the California Fire Assistance Agreement Committee (CFAA) was once again cancelled. The next meeting is anticipated to be scheduled sometime after mid-July.

## Safety/EMS Program

• 29 EMT Certification/Recertification Apps received in June (-43 from May). Current certified EMTs: 973 (-11 from May).

## **Training Program**

• Leadership Level I and II classes are still under development. CAL FIRE is contracting with the Blanchard Group and estimate completion by January 2020.

- Prescribed Fire Incident Commander is being developed with an estimated completion of July 2020.
- Aerial Supervision curriculum will be reviewed in August and sent to Statewide Training Committee for approval.
- Incident Management III Cadre to start the transition to C300 and C400. Class will be split into two separate classes to address the needs of command and control.
- Aerial Tree Operation Working Group scheduled to start work in August 2020.
- Fireline Safety Class ready for approval by August 2020.
- The new three-story dormitory is 95% completed (DGS Project). Still needing final punch list completed by contractor. Landscape has not started yet.

## Office of the State Fire Marshal

## Wildland Fire Prevention Engineering

- Defensible Space inspections are continuing throughout the state.
- Staff continue to analyze multiple proposed legislation on potential impact to Department and Program.
- Staff continue working with the Office of the State Fire Marshal Wildland-Urban Interface Building Code Committee in developing a list of low-cost home retrofits per AB-2911 (2018).
- Staff are working with the RPC Committee to update the power line exemption sections of 14 CCR 1250-1258.
- Staff continues to work on updating the Power Line Fire Prevention Field Guide.
- Staff are coordinating power line training with CAL FIRE Units and utility providers.
- Staff are working with CAL OES and the CPUC to improve Public Safety Power Shutdowns (PSPS) event notification.

## Fire Plan

• Units Fire Plans are being submitted for Region review. Approximately 23 of 27 Unit & Contract Counties have been received.

- Staff are working with the Fire Resource and Assessment Program (FRAP) and the Board to begin the SRA (State Responsibility Area) review. Following this review, a remapping effort of the Fire Hazard Severity Zones will begin.
- CalMAPPER is experiencing intermittent issues as upgrades occur. As a result, Unit & Regions are several weeks behind on updates to data (including the Fuels Reduction Activity Report/FRAR).

## **California Incident Data & Statistics Program**

- CAIRS program will be completely offline this August. CalFIRS program has been in service for six months and working well.
- Staff continues to conduct field training with CAL FIRE Units and local fire department agencies.

## Land Use Planning

- Representatives from the National Fire Protection Association met with the staff from the OSFM / Wildfire Prevention and Planning Division and BOFFP. They were provided an overview of efforts in fire prevention being conducted in the State.
- Firewise USA program continues membership growth. Significant increase in interest due to Fair Access to Insurance Requirements (FAIR) Plan opportunities. California continues to lead the nation with the most active communities totaling 217.
- Initiating hiring process for new staff associated with SB 2911 as it relates to subdivision analysis.

#### **Fire Prevention Grants**

- All (40) of the FY 18/19 "Community" Fire Prevention grant agreements have been executed. These are two-year grants primarily focused on Planning & Education aspects of Fire Prevention.
- All (26) FY 18/19 CCI Fire Prevention Grant agreements are in the process of being signed and approved. These are three-year grants primarily focused on hazard fuels reduction.
- FY 19/20 CCI Fire Prevention Grants should open the next application period later this summer.


