The draft report was compiled after the BART was demobilized and member returned to their primary work duties. One of my ongoing jobs was to make sure all specialist reports were submitted in a timely manner and the final draft submitted for review to the MASG. The final report detailed ongoing risk to those entering the burn area from slope stability problems that could lead to landslides and/or debris flows into the watercourses in and below the burn area. The report was delivered to County and City of Santa Barbara Emergency Response Personnel. The report included recommendations to protect residents and emergency response personnel entering the burn area.
