Lead a program to reduce fire risk by removing dead timber and excessive brush growth. Conducted intelligence gathering and target apprehension operations to combat international criminal organizations. Managed multi-million-dollar projects within the Department of Homeland Security's innovation profile and worked extensively with emerging technology companies at the operational level. - Partnered with the Resource Conservation District (RCD) of Greater San Diego County and the Audubon Society to develop a grazing management plan while becoming the first ranch in our region to become an Audubon Certified Conservation Ranch.
- Engaged with Point Blue Conservation Science and the Natural Resource Conservation Service (NRCS) to further implement conservation practices we have already started such as meadow reclamation and utilizing new fencing technologies.

- Directed the assignments and activities of fellow Supervisory Border Patrol Agents (SBPAs) and Border Patrol Agents (BPAs), across specialized units and teams, to fulfil mission priorities including preventing illegal entry of migrants into the United States by land and air.
- Apprehended smugglers and migrants within the El Cajon Station (ECJ) Area of Responsibility (AOR) and delivered consequences in accordance with various statutes and the criminal provisions of the Immigration and Nationality laws.
- Reviewed and approved various documents pertaining to criminal cases to include 8 USC 1324, 8 USC 1325, 8 USC 1326, and Title 21.
- Assigned schedules, approved leave, resolved disciplinary problems, and prepared annual performance appraisals for personnel on shift and various speciality units.
- Gathered and analysed intelligence utilizing the data to develop a process for redeploying personnel and surveillance assets to ensure the highest probability of resolving threats.
- Identified deficiencies in established communication, data, and information sharing practices, developed a solution, recommended the solution to management, and implemented the solution via Microsoft Teams and SharePoint across San Diego Sector.
- Managed the deployment and integration of the Android Team Awareness Kit (ATAK) into ECJ operations through a calculated daily, weekly, monthly, and quarterly plan.

- As (A) SBPA, for SDC SPT, I led the development and implementation of the SDC COVID-19 Pandemic Response Plan which was nested under the USBP HQ Operation Caprio Plan. Ensured effective collaboration between multiple USBP stations and sectors as well as many unique agencies and organizations during this historical event while minimizing the risk to the workforce, the public, and the agency.
- Developed and input station and sector level Operations Orders (OPORDS) into the Border Patrol Enforcement Tracking System (BPETS).
- Conducted a Capability Gap Analysis Process (CGAP) to assist stations and programs with identify and documenting agency gaps.
- Participated in the Operational Based Budget Process (ORBBP) which enables San Diego Sector (SDC) to determine how the deployment of resources, such as technology, infrastructure, and personnel, can be used to secure the border.
- Orchestrated weekly and monthly conference calls with the Office of the Commissioner and United States Border Patrol (USBP) Headquarters regarding the deployment of innovative technology assets in the SDC Area of Operations (AO) as well as other USBP Sector AOs.
- Designed, disseminated, and tracked station and sector campaign plans.
- Managed, monitored, and critiqued the performance of various companies within the Department of Homeland Security (DHS) Science & Technology Directorate to include the Silicon Valley Innovation Program (SVIP) profile.
- Developed server management protocols for the San Diego Sector Team Awareness Kit (TAK) server.
- Implemented and managed an audit process within my program and others to conduct the SAP inventory process on the programs throughout the year to ensure policy compliance.
- Designed, implemented, and fulfilled Systems Control Officer (SCO) polices, procedures, roles, and responsibilities for the Autonomous Surveillance Towers (ASTs).
- In conjunction with United States Border Patrol Headquarters, I coordinated the development and implementation of the ATAK Train the Trainer (T3) Course, End User Course, and National Policy.
- Ordered, received, inventoried, delivered, activated, and deployed over \$1.4 million in agent portable equipment, more specifically ATAK devices, across San Diego Sector. During the deployment I also ensured that all San Diego Sector law enforcement personnel were professionally trained in the use of ATAK.
- Oversaw and made recommendations to the Department of Homeland Security, Customs and Border Protection, United States Border Patrol Headquarters, and San Diego Sector Headquarters regarding the integration of legacy technologies and systems with the ATAK system. Some of the currently technologies I have helped to integrate with ATAK are ICAD4 Live, Mobile Surveillance Capability (MSC) Trucks, Lightweight Vehicle Surveillance System (LVSS) Trucks, Remote Video

Surveillance System (RVSS) Towers, Integrated Fixed Towers (IFT), ASTs, Small Unmanned Aircraft Systems (SUAS), Internet Protocol (IP) Cameras, Unattended Ground Sensors (UGS), and Communications Solutions.

- Researched innovative technologies leverageable by the Department of Homeland Security, Customs and Border Protection, and United States Border Patrol. Responsible for testing and evaluating innovative technologies deployed in the operational environment to support the diverse missions across the various agencies within the Department of Homeland Security and conducted analysis to determine areas of improvement.
- Led the development and implementation of innovative technology solutions for United States Border Patrol in conjunction with the Law Enforcement, US Military, and Intelligence Community. Responsible for developing deployment plans and ensuring that all stakeholders were aligned in their goals for each solution.
- Directed multi-million-dollar future capabilities testing and evaluation efforts to include the \$7 million AST Project. ASTs are an autonomous camera and radar system designed to use artificial intelligence to alert Border Patrol Agents to Items of Interest (IoI) in their Area of Responsibility (AOR). With the assistance of the Office of the Commissioner, efforts stemming from an initial four tower deployment in the Boulevard AOR expanded to cover three additional stations AORs; Campo, El Cajon, and Brown Field. A total of ten additional towers were procured and deployed in quarter two fiscal year 2019 and all fourteen towers were upgraded to the MK III variant during quarter one and two fiscal year 2020.
- Managed a joint United States Marine Corps (USMC) and Customs and Border Protection (CBP) pilot of the Autonomous Surveillance Tower Maritime (AST-M). The pilot was conducted on USMC Camp Pendleton (CAMPEN) and provided significantly increased domain awareness to the San Clemente (SCM) Border Patrol Station.
- Assisted in the development of the San Diego Sector SUAS Standard Operating Procedure (SOP). This led to the successful integration of SUAS into San Diego Sector operations which helped to provide increased domain awareness within key areas of the San Diego Sector AOR.
- Briefed the Department of Homeland Security Secretary and Customs and Border Protection Commissioner on the status of technology and infrastructure projects in the San Diego Sector AOR. This brief highlighted how a combination of technology, people, and infrastructure are needed to successfully obtain Operational Control (OPCON) with the San Diego Sector AOR.
- Spoke with members of the House Committee on Appropriations on the importance of making smart investments to address border security with a layered approach. This layered approach involves a combination of people, infrastructure, and mobile artificial intelligence powered technology. These approaches will allow the Border Patrol to effectively combat the ever-evolving border security threat.
- Directed a Capabilities and Limitations Test of Anduril Lattice System with Customs and Border Protection Innovation Office (CBP INVNT). This test assisted with and informed the creation of a new program of record at the Program Management Office Directorate (PMOD).
- Served as the SDC TAK Coordinator during the transition of the TAK Program from an innovation project to a program of record. I oversaw the program and ensured the

deployment remained uninterrupted while coordinating with the appropriate transitional partners to solidify the existence of the SDC TAK program in perpetuity.
