**Board of Forestry and Fire Protection**  
**Seeks Nominations for Professional Foresters Examining Committee (PFEC)**

The Board of Forestry and Fire Protection (Board) is requesting nominations for two (2) seats on the Professional Foresters Examining Committee (PFEC). PRC §763 establishes the PFEC as a committee of the Board consisting of at least seven or more members, and distributed as follows:

1. Two public members with one selected from the membership of the Board.
2. At least four Registered Professional Foresters (RPFs) representing a broad cross section of employment and expertise, and
3. At least one certified specialist pursuant to PRC §772.

As of January 15, 2021, there will be six (6) RPFs and one (1) certified specialist (CRM) member. There is one (1) public member on the committee and one (1) public member position remaining to be filled by a Board member. There are two (2) additional seats that can be filled immediately in the following categories:

- 1) Industry member (RPF)                      2) Government member (RPF)

The PFEC is charged with the examination of individuals for registration as RPFs and certified specialists (CRMs). It initiates and monitors investigations into complaints made against RPFs and recommends appropriate disciplinary action to the Board pursuant to 14 CCR §1612. The PFEC also provides oversight for the specialty certificate programs adopted by the Board.

PFEC members are generally appointed to a four-year term, serving at the pleasure of the board. The PFEC currently meets approximately 4 to 5 times per year, depending on the level of licensing and disciplinary issues. PFEC members receive per diem and re-imbursement of expenses for their travel, lodging and meals when attending meetings.

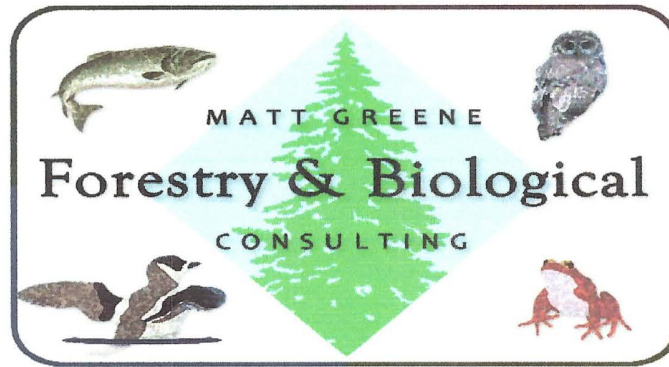

Dear Mr. Stapleton,

Attached with this letter is a recommendation for Matthew Brown to the PFEC for a RPF to represent the open industry position with this Committee.

I first met Matthew Brown in 2010 while sitting on the CLFA Board. He came into the group and gave a great presentation to the Board of Directors about how the ESA and NEPA have been weaponized. The presentation was a real eye opener as to how lawsuits are shaping the management on our federal forest lands. As a coastal forester, this topic doesn't always register as a high priority for most of our federal lands are more inland. However, this presentation stuck with me as he was able to get into the weeds about what these lawsuits were costing us, the tax payers.

Over the years, I have gotten to know him better and talked with him about several projects he was working on and especially how to work with his current employer, PG&E. He helped me gain a better appreciation of mastication projects on very steep slopes with self-leveling equipment. Additionally, I have gotten to better understand the mitigation banking concept as that is his current role with PG&E.

Living in Fresno County, Mr. Brown has also hung his shingle as a consultant to help the local small landowners navigate the massive beetle die-off that is occurring in the southern Sierra range. This is no easy feat when one considers that little to no management is happening on the largest landowner, who is a neighbor to most of these small landowners. Making things even more difficult is the complete lack of infrastructure, but Mr. Brown has turned to CFIP and EQIP to help these small landowners as much as possible.

Personal stories aside, there are a couple of reasons that I support Mr. Brown's nomination to the PFEC:

1. With his current knowledge of the utilities industry, I think that he brings a very valuable background to a larger conversation that you as a Board and the BOF are going to have (Winter 2020 Newsletter Article about powerline maintenance and if it is practicing forestry?). It is going to be important to have a line of communication to the utilities and I think Mr. Brown can represent both the license and his employer well. I think that he is also capable of separating the two when the topics requires a separation of representing the license and his employment.
2. As a consultant, I am always happy to see someone with a very diverse background on this committee as the profession covers such a broad range of topics. Consultants by the very nature of their work see a lot more of this broad range and this helps with various discussions that the PFEC has on a continuous basis.
3. As someone who grew up in the southern end of the central valley, I think it is important to have a point of view from that part of the state. It is often forgotten and unfortunately, this year a good amount of the areas damaged by beetles saw massive wildfire. We need to be reminded about some of these regional issues from time to time.

I am happy to nominate Matthew Brown to serve on the PFEC. I think he will represent the license well and I think he brings to the Committee more diversity which our profession continues to be tasked with.

Responsibilities also include overseeing the planning and management of habitat creation, restoration, and enhancement company-wide. These permits are all intended to support utility operations and maintenance and include development of Initial Studies, Finding of No Significant Impact, Environmental Impact Reports, Environmental Impact Statements, and Biological Assessments. The entire effort requires extensive collaboration/negotiation with agency personnel throughout California including the U.S. Fish and Wildlife Service (Arcata, Sacramento, San Francisco, and Ventura field offices), California Department of Fish and Wildlife (Region 2, 3, 4, and 6), US. Army Corps of Engineers (Sacramento, San Francisco, and Los Angeles Districts), Regional Water Quality Control Boards (Region 1, 2, 3, 5, and 6), as well as with State Water Board staff.
